# Pioneer Foods Competition Terms and Conditions/Rules

- 1. <u>Application</u>: Please read the competition terms and conditions ("Terms") carefully. These Terms apply to everyone entering the Bokomo Celebrate Your Kind of Breakfast and Stand a Chance to Win Competition ("the Competition").

#### 12. Instant Prizes

- (a) Winners will not be permitted to select alternative prizes or denominations of prizes, all prizes are predetermined and prizes are not transferable and may not be exchanged for other prizes.
- (b) The instant prizes are as follows:
  - i. Groceries
    - 1. Winners of the grocery prize will be given the option to choose between one of the three grocery prize vouchers on offer; Shoprite/Checkers, Pick n Pay or SPAR.

- i. The Consumer Protection Act legislates a validity period of three years for gift cards and vouchers. Only the person whose signature is on the card can use it. The Consumer signs their card in ink as soon as you receive it. The Consumers card must be cut in half once the funds have been spent or after the expiry date. Consumers will not be sent any correspondence or statements. We will always be the owner of the card. We reserve the right to limit the number of cards you may purchase.
- j. Consumers will not be able to use the card and voucher to purchase goods or services over the telephone or Internet.
- k. When the Consumer uses their voucher, they must sign a transaction slip. When the Consumers uses their card and voucher, we will process the transaction against their available card balance.
- No warranties, purchase protection, insurance, other promises, or services are provided. Once the Consumer has paid, they cannot stop payment of the transaction. Consumers are responsible for keeping track of the transactions on their card. The Card will not have a PIN.
- 4. **Pick n Pay:** The voucher entitles the Consumer to a Pick n Pay voucher up to the maximum value of R100 (one hundred Rand) or R500 (five hundred Rand), with the following conditions:
  - a. The Pick n Pay digital grocery voucher is governed by the following terms and conditions:
  - b. The voucher is valid for 12 (twelve) months from date of issue.
  - c. The Pick n Pay digital grocery voucher is exchangeable for merchandise at all Pick n Pay retail outlets, excluding all liquor and tobacco related products.
  - d. Misuse of this voucher, which shall be determined in Pick n Pay's sole discretion, constitutes fraud.
  - e. Pick n Pay digital grocery vouchers can be used as a valid tender on all products and services in-store, excluding all liquor and tobacco related products.
