

SHOPRITE HAIR & BEAUTY ME OCTOBER 2024 – R100 CHALLENGE TERMS & CONDITIONS

1. The promoter is Shoprite Checkers (Pty) Ltd ("the Promoter").

The promotional competition is open to all South African residents residing in South Africa and who are in possession of a valid identity document, passport or document of proof of South African residency.
